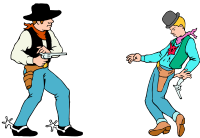

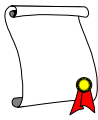

### RULES FOR SCRAPBOOK ENTRY

1. Each participating club must be a member of the Crescent Ski Council.
2. All materials included in the book must relate to the twelve months prior to the convention in which it is entered, i.e. from prior Spring Convention to the present Spring Convention.
3. Scrapbooks can be no smaller than 8 1/2 by 11 inches but no larger than a size easily handled. No winning cover (First Place) may be used again.
4. Scrapbooks must be signed in to the designated CSC Representative during CSC Check-in no later than 9 a.m. Saturday.
5. Judging will be done on Saturday by designated club member judges.
6. Books must be signed out by the club's designated representative.

Judges will use these four judging criteria and will also be looking for the following general suggestions.

### SCRAPBOOK JUDGING CRITERIA

1. **Inclusiveness and Organization** - A pictorial history of this year's events for the club, including Crescent functions.
2. **Originality and Creativity** - Give special consideration to originality and decoration.
3. **Theme** - Should be consistent throughout.
4. **Quality** - Use of graphics and non-photo items used for balance, but photos should be the mainstay.

### GENERAL SUGGESTIONS:

1. Look for balance between pictures and words.
2. Color should be pleasing to the eye.
3. Cover should be sized properly and durable.
4. Special features will be given extra credit.
5. Photos should be of good quality and presented in a pleasing manner.
6. The book should be entertaining and informative for any one seeing the book, not just the club. Think of it as a tool for membership recruitment.

7. Publishing of member club sponsors, supporters (logos, advertising, evidence of promoting local business sponsors?)
8. Membership, meetings information (date, time, location, agenda, contacts)
9. Can it be used to attract new members and inspire members to get involved? (Yes / Some / Not much help)
10. Events activities signup instructions (Who to contact, price, dates, what's included)
11. Calendar of Events (easy to use calendar to view overall activities)
