Attention All Members

As required by our by-laws, this is official notice of changes made to the by-laws by the Board of Directors. The applicable section is:

- 8.2 These by-laws may be amended at any regularly scheduled meeting of the Board of Directors by a two-thirds vote of all the members of the Board of Directors. The changes will be published in the newsletter preceding the next regularly scheduled membership meeting. Any member may require the amended by-laws be voted on and approved by two-thirds of all voting members present at the next regularly scheduled membership meeting.

During the 2002-2003 Board of Directors term a by-law revision committee was formed and met a number of times. Two types of changes were made. The first were 'editorial' changes. These consisted of corrections to obvious errors, such as the one that stated that officer elections would be held at the April meeting, (elections are in March, the installation is in April,) and changing all references to 'he', 'she', or 'he/she' to be gender neutral, (for example 'the President', 'the member', or 'the director'.) These changes were approved by the Board at the April 2003 board meeting.

The second type of change was to the section governing the make-up of the Board of Directors. These changes consisted of adding new responsibilities to some positions, such as maintenance of the club web page and forwarding E-Mail notices of ski club and CSC events to the Board or general membership, and the consolidation and/or removal of overlap of responsibilities of certain board positions. These changes were not approved at the April 2003 board meeting but were revisited and approved at the February 2004 board meeting.

Copies of the new by-laws will be available for review by the membership at the March 2004 club meeting at the Arts Center.
