NOTE In hopes to increase participation from clubs we have continued to budget into the cost of the trip a ½ reimbursement for a (1) trip leader per club per 25 respective adult club members paid. This is based on full occupancy in a 2BR for 2 nights and includes lift ticket. Reimbursements will be issued after the trip to-no exceptions. Reimbursements will be issued to the trip leader with the checks made out to the respective club to be distributed per club policy.

#### **DEADLINES FOR 2006-2007 CRESCENT RACE/SKI WEEKENDS**


