
But we are still going to have some fun in the summer & with those lingering "dog days" in the fall!

A "walk-in" daily rate of \$140 is also available. All KVC pricing for this trip is based on one parent/grandparent per child participating in the adult lesson package, otherwise regular published rates apply. Also, Trip Leader must be informed prior to trip.
